We just got off the phone with a friend in NZ, and he was telling us about the separation camps of vaccinated/unvaccinated citizens. Dear Commissioners Garrido, Wolfe, and Gelder,

I can't believe we're doing this again.

I am writing to beseech you to not implement vaccine passports in Kitsap County or to enforce that businesses require their employees to be vaccinated.

Some have suggested we should implement these coercive vaccination policies such as those used during the smallpox pandemic of the early twentieth century. COVID-19 rises not remotely to the level of smallpox, which it is estimated had a 30% mortality rate among the infected. In comparison, the mortality rate of COVID-19 is now established to be well below 1%.

Should those at real risk have access have voluntary access to the vaccine? Absolutely! Should the untold millions who have already had COVID-19 be forcibly vaccinated? No. Natural immunity has worked for the human race and has kept us alive for millions of years, and there is no reason to believe it has stopped working now.

Should those under twenty for whom COVID-19 is practically harmless be forcibly vaccinated? No. If anything, the focus of scientists should turn to developing a vaccine for the current strain of the virus, which has not been done and appears to be no one's priority. Is this a free country? It has been in the past, and it is up to people like you to keep it that way and protect your constituents' freedoms. It is clear that the federal government no longer

cares about our individual freedoms, so it is up to us, you and me, to stand up for them.

Natural selection is real; humanity is not immune to it. COVID-19 will continue, as it is, to circulate amongst the vaccinated and the unvaccinated. Masks, as has been observed by military germ warfare researchers, will continue to provide as much protection as a chain link fence against a swarm of bees.

Meanwhile, Kitsap County, as you observed, leans on medical facilities, and is experiencing an exodus of medical personnel due to our COVID policies. Treatment for all other ailments is getting deferred, accentuating co-morbidities. We are becoming sicker and more susceptible not only to COVID-19 but to a plethora of other ailments as well, both physical and mental.

I ask you, have you considered what Kitsap County will look like a week after vaccine passports are mandated? How about a month? A year? How many Kitsap County residents will be forced to leave their jobs, their homes, their very lives in order to escape authoritarian mandates, even just to have the ability to buy food for their families? What effect will that have on the local economy, how many businesses will close their doors, how many American dreams will have died? You are not only entrusted with protecting the short and long-range success of the county, but also the lives, well-beings, and freedoms of the people residing in it. Please do not punish people for trying to live their lives the way they want to.

If you want to do something truly productive in the fight against COVID-19, consider a serious campaign encouraging exercise and sound dietary practices. The more than eighteen months since this pandemic began was ample time for the average individual to significantly fortify their health with sound lifestyle improvements, but your sector has utterly squandered that time and we are all suffering because of it.

The proposed mandatory vaccination policy is treasonous, and we will do everything we can to assure that those promoting it are stripped of their influence and are relegated to the ranks of the unemployed.

Stand for us. We elected you to represent us and administer the policies we want to see in place in our community, not to enforce unlawful and unreasonable mandates that come from the federal government to try and control us. Be a part of the solution, not the problem.


