Re: COVID-19 Update – Current Impacts to Local Healthcare and Emergency Medical

Services in Kitsap County

During the Health Board's regular meeting on September 7, 2021, board members asked the Health District to schedule a special meeting to present and discuss the current impacts of the COVID-19 pandemic on our local healthcare system and possible solutions to stabilize the continuum of care in our community. Today, I will be joined by Fire Chief John Oliver of Central Kitsap Fire and Rescue and the Chair of the Kitsap County EMS Council, Dr. David Weiss, Associate Chief Medical Officer for St. Michael Medical Center, and Elizabeth Klute, Director of Kitsap County Department of Emergency Management.

Background

COVID-19 disease transmission remains at its <u>highest level of the pandemic in Kitsap County</u>, with over 700 new cases diagnosed each week since mid-August. This has resulted in over 219 hospitalizations of Kitsap residents in the past 30 days, 11 active outbreaks in long-term care facilities involving over 250 residents and staff, and at least 28 deaths in the first three weeks of September, alone. Furthermore, more deaths are expected as reconciliation of death data may take several weeks to be completed.

This surge in disease activity, driven by the highly transmissible Delta variant and most severely impacting the unvaccinated, is critically straining a depleted and fragile healthcare system, which is now operating at levels approaching "crisis standards of care". According to the Institute of Medicine¹:

"Crisis standards of care" is defined as a substantial change in usual healthcare operations and the level of care it is possible to deliver, which is made necessary by a pervasive (e.g., pandemic influenza) or catastrophic (e.g., earthquake, hurricane) disaster. This change in the level of care delivered is justified by specific circumstances and is formally declared by a state government, in recognition that crisis operations will

be in effect for a sustained period. The formal declaration that crisis standards of care are in operation enables specific legal/regulatory powers and protections for healthcare providers in the necessary tasks of allocating and using scarce medical resources and implementing alternate care facility operations.

Our panelists today will address how outbreaks and infected staff --- primarily unvaccinated staff --- in nursing homes have delayed patient discharges from the hospital, contributing to the already high COVID-19 inpatient census levels at the hospital (currently in the mid-60's), which in turn has resulted in the need to "board" new admissions in the Emergency Department at the hospital for up to three days or longer. Boarding new admissions in the Emergency Department means that there are not sufficient beds available to handle incoming emergency patients.

Intermittent bottlenecks at the Emergency Department have led to significant delays in EMS drop-offs from ambulances. When ambulances are delayed at the hospital it means that they are essentially "taken out of service" for the duration of the delay, resulting in a shortage of emergency medical services staff and ambulances at a time when the need for their services is already at critically high levels. This has led to periods during which emergency medical services are unavailable or severely degraded in Kitsap communities. Additional impacts include ongoing delays of non-urgent surgical procedures for issues such as joint replacements, cancer resections, cardiothoracic interventions, or other surgeries that may require inpatient admission.

This situation has reached a point where it has become an emergent community health issue. Staffing at our local healthcare facilities remains a critical challenge due to personnel shortages. Just this week, to address the healthcare personnel shortages in Kitsap and the rest of Washington state, the state Department of Health has formally requested 1,200 clinical and non-clinical staff to assist statewide through the federal General Services Administration, and our Emergency Operations Center (EOC) is recruiting volunteers from our local Medical Reserve Corps to assist locally.

The Health District and EOC have activated a multi-agency response to evaluate ways to decompress the overburdened healthcare system by supplementing depleted staff in the hospital and post-acute care facilities, stand up new alternative care facilities including triage tents at the St. Michael Medical Center (SMMC) Emergency Department, and possibly opening new post-acute care facilities. Participants in these discussions have included the Northwest Healthcare Response Network, our local hospital system, Kitsap Emergency Operations Center, the Washington State Department of Health, Kitsap EMS Council, and the Medical Reserve Corps. Kitsap Public Health District has also been asked to participate in a healthcare coalition to address opportunities for stabilizing the workforce in long-term care facilities.

Summary and Next Steps

The continuum of care in the Kitsap County healthcare system is severely strained after months battling this pandemic and is, at times, approaching the blurred borders of "Crisis Standards of Care," in which health systems and providers are required to openly deviate from usual standard or care or use criteria to ration or selectively administer limited resources. This means that medical staff may have to choose between who gets care and who doesn't. This has happened already in northern Idaho, Alaska, Montana, and parts of the southwest, and is at risk of happening in Washington State and Kitsap County, which under the best circumstances already have some of the lowest numbers of hospital beds on a per capita basis nationally.

Vaccinations are the best tool --- really the only tool if we want to keep the economy and schools open --- to prevent this potential disaster and mitigate the impacts of this pandemic on individual and community health, on our healthcare system, and on the collateral damage to our economy, businesses, schools, and government.

Kitsap Public Health District has implemented its own vaccination requirements for its employees to protect its workers and the people it serves, and we recommend that all governmental agencies in Kitsap immediately resolve to implement vaccination requirements for their employees at this time, as now required in Washington state under recently issued federal mandates for large employers. We firmly believe that government should lead the way in this effort if we expect others to follow.

The Health District also strongly recommends that local businesses in the hospitality and entertainment sectors voluntarily enact vaccination requirements for employees and patrons at this time, similar to what the Admiral Theatre has done as you heard about during your September 7th meeting.

During today's meeting, it is our goal to discuss and get direction from the Board about other measures to take to address this critical stage of the pandemic in Kitsap County.

Recommended Action

While the Health District recognizes that vaccination requirements are a complex and controversial topic to some, we hope to receive direction from the Health Board on how you would like to proceed with respect to the following, or other, options:

- 1. Take no action and allow the current situation to play out.
- 2. Make a formal Health Board recommendation/resolution for all local governmental agencies to require vaccination for their employees.
- 3. Make a formal Health Board recommendation/resolution for all private businesses to require vaccination for their employees and/or require proof of vaccination for entry into indoor public places.

- 4. Issue a formal Health Board / Health Officer order under the authority of RCW 70.05 to require employee vaccinations at governmental agencies.
- 5. Issue a formal Health Board / Health Officer order under RCW 70.05 to require all business open to the public, or indoor venues open to the public, to require proof of vaccination for entry.

Below are my comments to be considered in relation to the Special Meeting taking place tomorrow, Tuesday, September 28, 2021.

Do you ever wonder why there is an ever-increasing distrust in government lately? It wouldn't be difficult to see if those in government took the time to strip away their bias and ideology driven agendas and be truly open, honest and show what real integrity looks like. Looking at the people of your community not as people to be lead or governed but as your friends and neighbors that need you to recognize that solutions to problems (or perceived problems) are not simply black and white or have only one avenue in which to achieve a goal.

The problem with elected government leaders and non-elected governmental agency officials during this never ending COVID situation is that they fail recognize that so many decisions that have been made over this time have been confusing, contradictory, dismissive of valid questions and concerns, overreaching, illogical, and frightening to be honest. So many decisions that have been made and forced upon the populace since March 2020 has done more to destroy what trust the people had in the government than made to feel safe. With now the consideration of vaccine passports and/or mandates for vaccines only deepens this distrust. The people are no longer allowed to live and make decisions as adults. This is not how a free people are supposed to live.

When the virus first reached us, I know there were few that did not want to do whatever they could to stay safe and help the cause. Our family was no different. We stayed home and were very

careful about what we did during the beginning months. But after a time, it was clear that this was going to be situation we would all have to learn to live with and we needed to get on with our lives. It was also clear that this situation was going to be exploited by the government. If it wasn't exploitation, then it was incompetence at best. Either option is not acceptable.

Since the beginning, there has been so much confusing and illogical actions taken by our government agencies that it has been incredibly frustrating. We kept hearing about how decisions are driven by science and data, but it was clear the government was utilizing their own secret science and data. When ridiculous policies and protocols are put out as serious measures, all we can do is shake our heads and do our best to get around them. But they just kept coming, regardless of new studies and other new scientific information and data, the government has doubled down on restrictive protocols, policies and mandates. And with each one, the distrust and division grows. But they keep coming at us. It feels as if we are going backwards and not forwards with no light at the end of the tunnel.

One blaring and primary fact that continues to get ignored is the simple chance of surviving a case of COVID for most people under the age of 60 and in good health is over 99%. Why such draconian measures for this kind of survival rate? Would it not make more sense to protect the vulnerable and let the younger and healthier people continue keeping the world moving? This is what the vulnerable have always done as it is. They don't go out as much, they avoid large crowds and stay away from people when they know they are sick. It's common sense. What we have been doing is nothing of the sort.

We have spent over a year and a half hearing about cases, cases, cases to ad nauseum. We used to hear about herd immunity but somewhere along the line talk of it disappeared. Between all the people that are vaccinated against COVID and the substantial number of positive cases over this time, one would think we are reaching herd immunity. Or maybe we never had all those cases in the first place? Which is it? Not to mention all the cases that have never been recorded.

Another bizarre and confusing aspect of all this is the lack of recognition of natural immunity. The distrust in the medical field is also growing because if this strange omission of natural immunity. It has been completely disregarded and that is very disturbing. Per the CDC it is stated as follows:

"Active Immunity results when exposure to a disease organism triggers the immune system to produce antibodies

to that disease. Active immunity can be acquired through natural immunity or vaccine-induced immunity.

Natural immunity is acquired from exposure to the disease organism through infection with the actual

disease.....if an immune person comes into contact with that disease in the future, their immune system will recognize

it and immediately produce the antibodies needed to fight it. Active immunity is long-lasting, and sometimes life-long."

Even though the CDC still pushes the vaccine regardless of previous infection, a look at what is happening in Israel should be eye opening and seriously considered. Isn't building immunity the goal? Wouldn't it be good and appropriate medicine to recognize natural immunity as a reasonable path to this goal?

There are numerous people that have had COVID and were unaware. There are many that have antibodies and the antibody tests are showing this. Why does the science regarding COVID not find it prudent and useful to know how many people have existing antibodies and how long they remain? Would this not be valuable data?

The rabid push for all to get vaccinated regardless of previous infection, health status, allergies, etc., is very disturbing to say the least. In assessing my personal risk with consideration of my age and health profile, I literally have a higher risk of injury or death from the vaccine than I would from the virus. Being forced to take a vaccine that, for me, would be like playing Russian roulette and it terrifies me. I feel as if I am being expected to risk my life for the sake of others even though me getting the vaccine provides no true benefit to others. If there is a benefit, it would only be for myself. There seems to be zero concern or understanding that there are people who absolutely cannot get these vaccines or risk death. But they are told it doesn't matter if they want to keep their job or go into a grocery store. How is this acceptable? What have we become?

The idea of vaccine passports is probably the most heinous and draconian measure any governmental body could ever inflict on their community. For those that propose this type of policy clearly disregard the fact that the vaccine is not preventing the spread of the virus or the contraction of the virus by the vaccinated. Again, look at Israel. I personally know more vaccinated people that have tested positive for COVID and ended up very ill than I do of those unvaccinated. Also, consider that as reported by MSN Health in August 2021,

"Fully vaccinated adults can carry the same amount of coronavirus as those who are unvaccinated, according to a new study.

Researchers from the University of Oxford found the viral load reduction can be wiped out by the Delta variant which is now dominant in the UK."

Are vaccine passports really going to be the answer? Is the promotion of segregation, discrimination and second-class citizenship for members of your community really acceptable to you? Do you not realize how this will only multiply the anger, the anxiety, and frustration that so many people already are experiencing to date? How is this going to make life better for people? How are the businesses, already short staffed and struggling going to navigate around this type of thing? Not only will you have the unvaccinated not spending their money in these businesses, but you will also have many vaccinated customers also refusing to "show their papers." These businesses will now suffer insult onto injury if vaccine passports are implemented. It is interesting how we were told many months ago that this type of thing would never happen and were silly to even think such a thing. But here we are. These measures are not going to encourage those unvaccinated to all run in and get their shots. Most people who have not gotten the vaccinations by now are pretty well set on that decision. They have analyzed their own risks and have decided what is best for them. In fact, this pushing to vaccinate, from the scare tactics, the flattery, the bribing and now downright coercion actually makes me even more distrustful of it all. Those giving in at this time are only doing it out of fear and under duress, and that is not Informed Consent.

Additionally, consider the tourists, visitors and new residents to this county. How unwelcoming it will be to learn that their presence is not allowed or tolerated unless they

are vaccinated. There are so many scenarios where people in this county will be negatively affected by vaccine passports. These measures will cause more harm than good and most reasonable people recognize this fact.

If vaccine passports are implemented in any way in this county, my family will simply not do business in Kitsap County. I'd rather be treated like a first-class citizen in another county, even if it means driving farther and doing more all-day shopping to lessen the trips, than be treated as a second-class citizen and assumed diseased human in my own county, if that's what I will have to do.

Ultimately, the sad reality is and best solution for my family will be leaving the county and probably the state altogether to live in an area that respects individual liberties and bodily autonomy (something I thought the medical field held in high regard.) I thought Kitsap County, a military area, was a place that believed in freedom, diversity and equality. I hope it still does but it can only remain if those in power are honorable enough to ensure these qualities are not compromised by ideology, an agenda or misguided decisions. Please recognize that the citizens of this county are capable of making the right decisions that are best for themselves and their families without the constant interference of local governing bodies. It's time to end this insanity by not allowing anymore division in this county than we already have. This is not a path to unity.

When ridiculous policies and protocols are put out as serious measures, all we can do is shake our heads and do our best to get around them. But they just kept coming, regardless of new studies and other new scientific information and data, the government has doubled down on restrictive protocols, policies and mandates. And with each one, the distrust and division grows. But they keep coming at us. It feels as if we are going backwards and not forwards with no light at the end of the tunnel.

One blaring and primary fact that continues to get ignored is the simple chance of surviving a case of COVID for most people under the age of 60 and in good health is over 99%. Why such draconian measures for this kind of survival rate? Would it not make more

sense to protect the vulnerable and let the younger and healthier people continue keeping the world moving? This is what the vulnerable have always done as it is. They don't go out as much, they avoid large crowds and stay away from people when they know they are sick. It's common sense. What we have been doing is nothing of the sort.

We have spent over a year and a half hearing about cases, cases, cases to ad nauseum. We used to hear about herd immunity but somewhere along the line talk of it disappeared. Between all the people that are vaccinated against COVID and the substantial number of positive cases over this time, one would think we are reaching herd immunity. Or maybe we never had all those cases in the first place? Which is it? Not to mention all the cases that have never been recorded.

Another bizarre and confusing aspect of all this is the lack of recognition of natural immunity. The distrust in the medical field is also growing because if this strange omission of natural immunity. It has been completely disregarded and that is very disturbing. Per the CDC it is stated as follows:

"Active Immunity results when exposure to a disease organism triggers the immune system to produce antibodies to that disease. Active immunity can be acquired through natural immunity or vaccine-induced immunity.

Natural immunity is acquired from exposure to the disease organism through infection with the actual disease...

...if an immune person comes into contact with that disease in the future, their immune system will recognize it and immediately produce the antibodies needed to fight it. Active immunity is long-lasting, and sometimes life-long."

Even though the CDC still pushes the vaccine regardless of previous infection, a look at what is happening in Israel should be eye opening and seriously considered. Isn't building immunity the goal? Wouldn't it be good and appropriate medicine to recognize natural immunity as a reasonable path to this goal?

There are numerous people that have had COVID and were unaware. There are many that have antibodies and the antibody tests are showing this. Why does the science regarding COVID not find it prudent and useful to know how many people have existing antibodies and how long they remain? Would this not be valuable data?

The rabid push for all to get vaccinated regardless of previous infection, health status, allergies, etc., is very disturbing to say the least. In assessing my personal risk with consideration of my age and health profile, I literally have a higher risk of injury or death from the vaccine than I would from the virus. Being forced to take a vaccine that, for me, would be like playing Russian roulette and it terrifies me. I feel as if I am being expected to risk my life for the sake of others even though me getting the vaccine provides no true benefit to others. If there is a benefit, it would only be for myself. There seems to

be zero concern or understanding that there are people who absolutely cannot get these vaccines or risk death. But they are told it doesn't matter if they want to keep their job or go into a grocery store. How is this acceptable? What have we become?

The idea of vaccine passports is probably the most heinous and draconian measure any governmental body could ever inflict on their community. For those that propose this type of policy clearly disregard the fact that the vaccine is not preventing the spread of the virus or the contraction of the virus by the vaccinated. Again, look at Israel. I personally know more vaccinated people that have tested positive for COVID and ended up very ill than I do of those unvaccinated. Also, consider that as reported by MSN Health in August 2021,

"Fully vaccinated adults can carry the same amount of coronavirus as those who are unvaccinated, according to a new study.

Researchers from the University of Oxford found the viral load reduction can be wiped out by the Delta variant which is now dominant in the UK."

Are vaccine passports really going to be the answer? Is the promotion of segregation, discrimination and second-class citizenship for members of your community really acceptable to you? Do you not realize how this will only multiply the anger, the anxiety, and frustration that so many people already are experiencing to date? How is this going to make life better for people? How are the businesses, already short staffed and struggling going to navigate around this type of thing? Not only will you have the unvaccinated not spending their money in these businesses, but you will also have many vaccinated customers also refusing to "show their papers." These businesses will now suffer insult onto injury if vaccine passports are implemented. It is interesting how we were told many months ago that this type of thing would never happen and were silly to even think such a thing. But here we are. These measures are not going to encourage those unvaccinated to all run in and get their shots. Most people who have not gotten the vaccinations by now are pretty well set on that decision. They have analyzed their own risks and have decided what is best for them. In fact, this pushing to vaccinate, from the scare tactics, the flattery, the bribing and now downright coercion actually makes me even more distrustful of it all. Those giving in at this time are only doing it out of fear and under duress, and that is not Informed Consent.

Additionally, consider the tourists, visitors and new residents to this county. How unwelcoming it will be to learn that their presence is not allowed or tolerated unless they are vaccinated. There are so many scenarios where people in this county will be negatively affected by vaccine passports. These measures will cause more harm than good and most reasonable people recognize this fact.

If vaccine passports are implemented in any way in this county, my family will simply not do business in Kitsap County. I'd rather be treated like a first-class citizen in another county, even if it means driving farther and doing more all-day shopping to lessen

the trips, than be treated as a second-class citizen and diseased human in my own county, if that's what I will have to do.

Ultimately, the sad reality is and best solution for my family will be leaving the county and probably the state altogether to live in an area that respects individual liberties and bodily autonomy (something I thought the medical field held in high regard.) I thought Kitsap County, a military area, was a place that believed in freedom, diversity and equality. I hope it still does but it can only remain if those in power are honorable enough to ensure these qualities are not compromised by ideology, an agenda or misguided decisions. Please recognize that the citizens of this county are capable of making the right decisions that are best for themselves and their families without the constant interference of local governing bodies. It's time to end this insanity by not allowing anymore division in this county than we already have. This is not a path to unity.
