Dear Mr. Grellner,

I've been watching the Kitsap County Public Health Board Meetings for several months now.

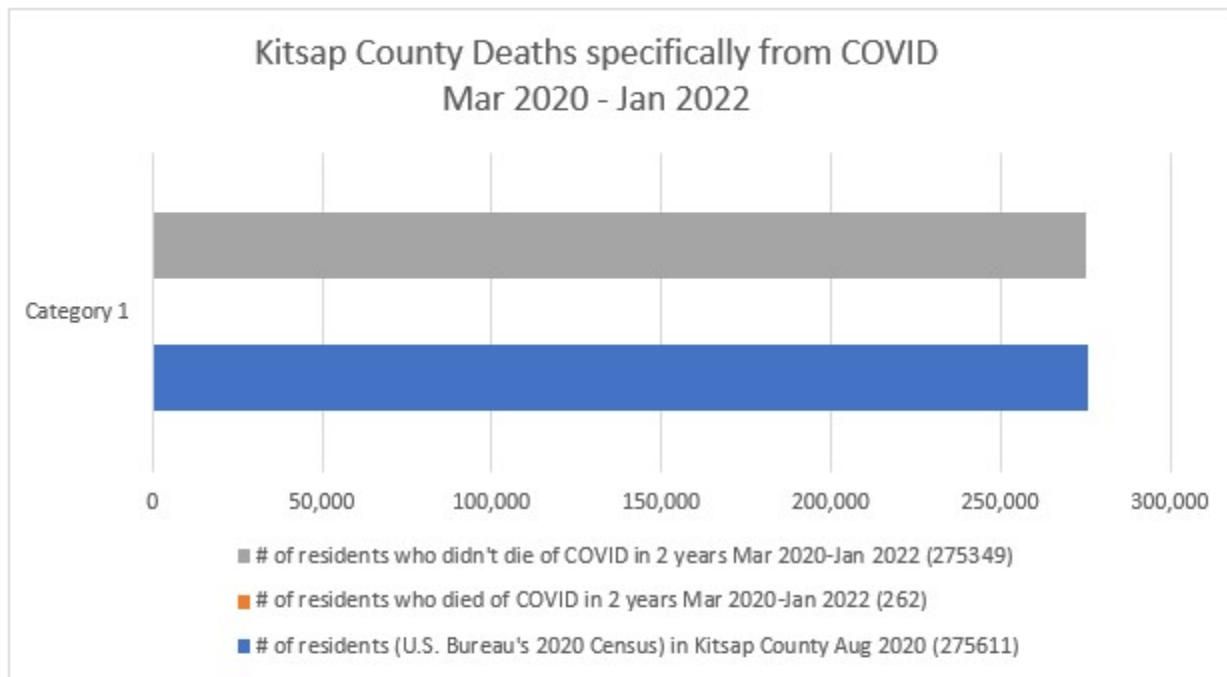

My children are ages 8 and 11 and have been to our house and school, the houses of family and friends but I no longer take them to stores, libraries, events or any place where we are required to wear uncomfortable masks. It's just not worth it. Masks help so little and are so gross. It's way to humid to not see it as a collector of grossness that you stick to your face and continue to wear for hours on end. I have lived in Kitsap County since 1986. I went to NK schools myself from kindergarten to graduation. To whomever is considering requiring COVID-19 vaccines for children in WA state to receive schooling or childcare:

Please protect children's civil rights in WA state, I implore you to say NO to mandating COVID-19 vaccines for children in order to receive schooling and childcare. I am a WA resident, citizen, parent, and teacher. I am against your proposed discrimination against children in the worst form- stopping a child's education and ability to advance in society simply based on their vaccine status.

What WA State Board of Health is proposing, is outright discrimination against children to receive education and childcare services in WA state based on their parent's informed and rightful healthcare decision. I am against discrimination of ALL kinds- including discrimination of COVID-19 vaccine status. Denying a child an education based on any kind of status is unethical treatment of people and I stand against it. Forcing children to have a vaccine to be educated would be a systemic discrimination bully tactic, to squeeze parents to decide on a vaccine that still has potential unknown risks and does not prevent the transmission of COVID-19.

We are the moms and dads, as moms, we gave birth to these children that happen to reside in WA state. As parents we are the ones that love and care for them- it is not the place of the state to force any healthcare decision upon parents for their children.

Policies and decisions can have unintended consequences. Furthermore, what will be next? Shall a child be prevented from participating in any part of society unless they have this particular vaccine? Let's face it, WA state has a bigger problem that needs immediate attention, WA state is failing in many areas of public education in basic areas of math, science, language arts - students are graduating without basic grade level understanding of basic subjects (<https://washingtonstatereportcard.ospi.k12.wa.us/>). WA state was failing children in their education before the pandemic, I cannot imagine how over a year of children on a computer has improved these numbers and now pushing this decision. There are teacher and substitute shortages- I am actually certified teacher in the schools and if you mandate this, I would have to consider other alternatives, if you forced this mandate. Consider basic civil in America: Check out HHS.gov- from their website as of January 6, 2022: "What are civil rights?

Civil rights are personal rights guaranteed and protected by the U.S. Constitution and federal laws enacted by Congress, such as the Civil Rights Act of 1964 and the Americans with Disabilities Act of 1990. Civil rights include protection from unlawful discrimination. The HHS Office for Civil Rights (OCR) enforces civil rights laws that prohibit discrimination on the basis of race, color, national origin, disability, age, religion, and sex (including pregnancy, sexual orientation, and gender identity) by certain health care and human services entities:

state and local social and health services agencies, hospitals, clinics, nursing homes, insurers who are participating in the Marketplaces and receiving premium tax credits, and other entities receiving federal financial assistance from HHS.

Under these laws, all persons in the United States have a right to receive health care and human services in a nondiscriminatory manner. For example, you cannot be denied services or benefits simply because of your race, color, national origin, or disability. For more information about these laws and our authority under them, see our Civil Rights home page."

Also, "The Civil Rights Act of 1964 is the nation's benchmark civil rights legislation, and it continues to resonate in America. Passage of the Act ended the application of "Jim Crow" laws, which had been upheld by the Supreme Court in the 1896 case Plessy v. Ferguson, in which the Court held that racial segregation purported to be "separate but equal" was constitutional. The Civil Rights Act was eventually expanded by Congress to strengthen enforcement of these fundamental civil rights." Not only will you be segregating children due to their COVID-19 vaccine status, you will be excluding them from an education altogether. This will be a shameful stain on WA state's history should you enact this. Please refer to [WAC 246-105-030](#). Despite getting the COVID-19 vaccine, the disease will still be transmissible, it is not preventable: "Vaccine-preventable diseases children must be protected against for full immunization. In accordance with the conditions of this chapter, a child is required to be vaccinated against, or show proof of acquired immunity for, the following vaccine-preventable diseases before attending school or a childcare center)."

What happened to informed consent? Parents can make informed decisions for their children and if you disagree with it, that is okay, this is a free state in a free country, we are free people to decide what we want for ourselves and our children. We are the healthcare decision makers for our children. Parents have valid concerns to choose against the COVID-19 vaccine for their child and it is their family business what they decide. There is still little research on the long-term effects that could occur in children, this is a valid concern for parents, and they should be allowed to give pause to this decision. When I talked to a local pediatrician it is clear not much is known about the vaccine and children who have already had COVID-19. This, along with a host of other factors influence decision-making and these factors must remain private and respected. Parents do not need to give a reason why or "exemption status", it is a personal decision. The next aspect to discuss is the legality and how federal code encapsulates the Nuremberg Code, which is an important legal framework surrounding medical experiments. Under 21 code of Federal Regulations Section 50.23 and 50.24, it is absolutely illegal to make anyone participate in an experimental program using coercion. This is how we have embraced the Nuremberg Code in US law. Under 18 US Code Section 2331 subsection 802, inside of the definition of domestic terrorism, anytime a citizen or government agency is forced to do something against their will with coercion, this is domestic terrorism. Indictments for domestic terrorism have been filed in all 50 states against individuals and organizations at the federal level attempting to mandate illegal experiments against the Nuremberg Code.

The next aspect to discuss is the legality and how federal code encapsulates the Nuremberg Code, which is an important legal framework surrounding medical experiments. Indictments for domestic terrorism have been filed in all 50 states against individuals and organizations at the federal level attempting to mandate illegal experiments against the Nuremberg Code.

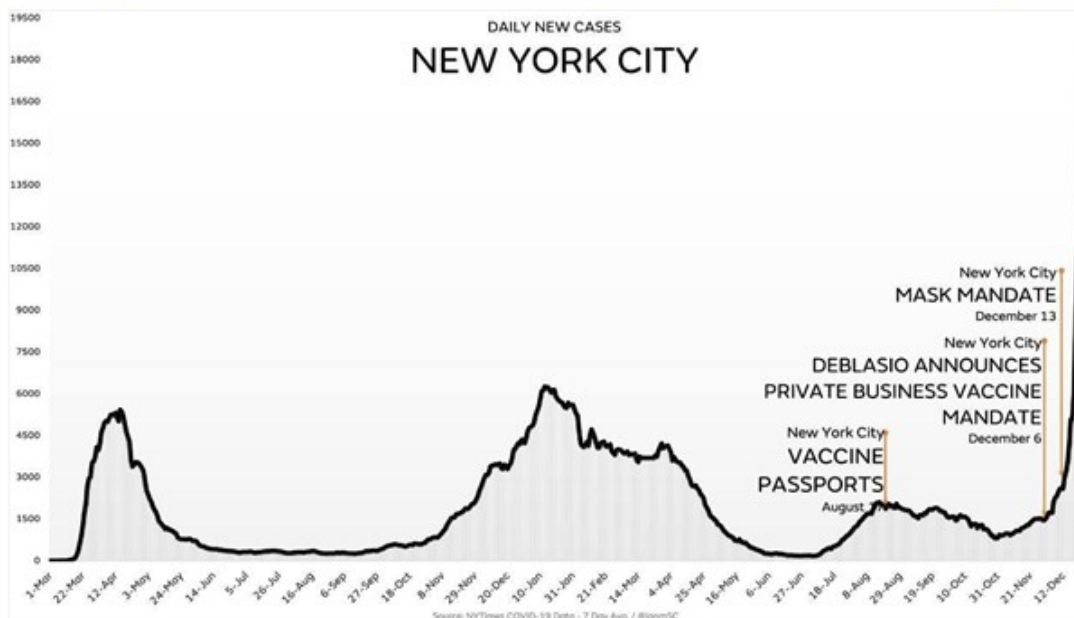



Good morning,

I am again writing to express my concerns about the possibility of requiring proof of vaccination to access businesses and services in Kitsap County. My previous comments are included below and I write again because over the last month, any value these policies were touted to have has completely disintegrated. More and more fully vaccinated and boosted individuals are getting and spreading COVID. **There is less reason now than ever to implement such policies.** They only serve to strip away our freedom and would erode any faith the community has left in public health institutions. There is absolutely no scientific data to support restricting unvaccinated individuals access and ability to support local businesses. These vaccines do not serve as an effective way to prevent the transmission of the virus. They might be useful to prevent severe disease in some, but the products also come with risks that some individuals cannot justify. These policies do not take into account medical or religious exemptions. Successful vaccine rollouts have failed to stop Covid transmission, with new data showing the prevalence of the virus increasing in "fully" vaccinated individuals. 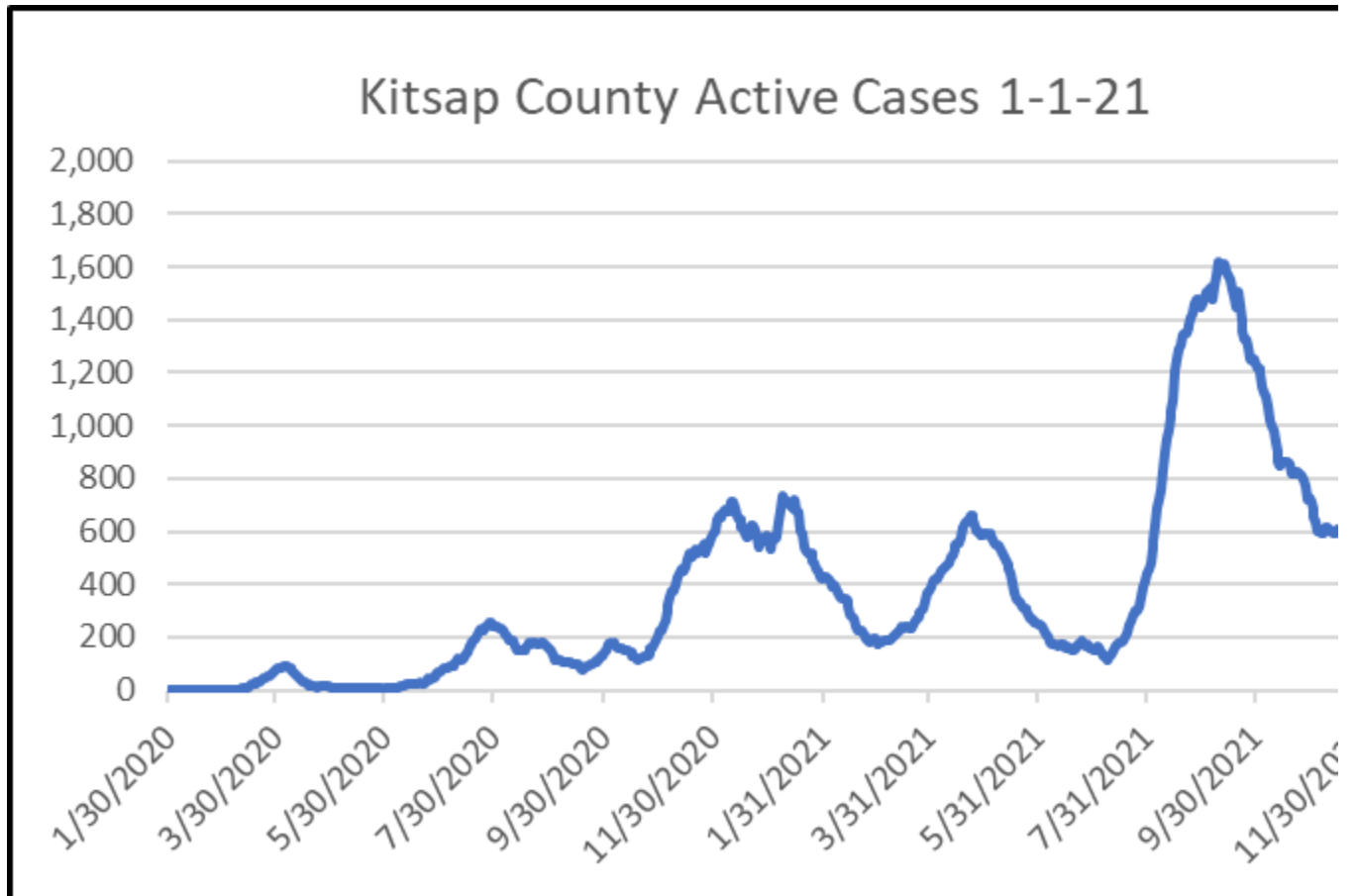

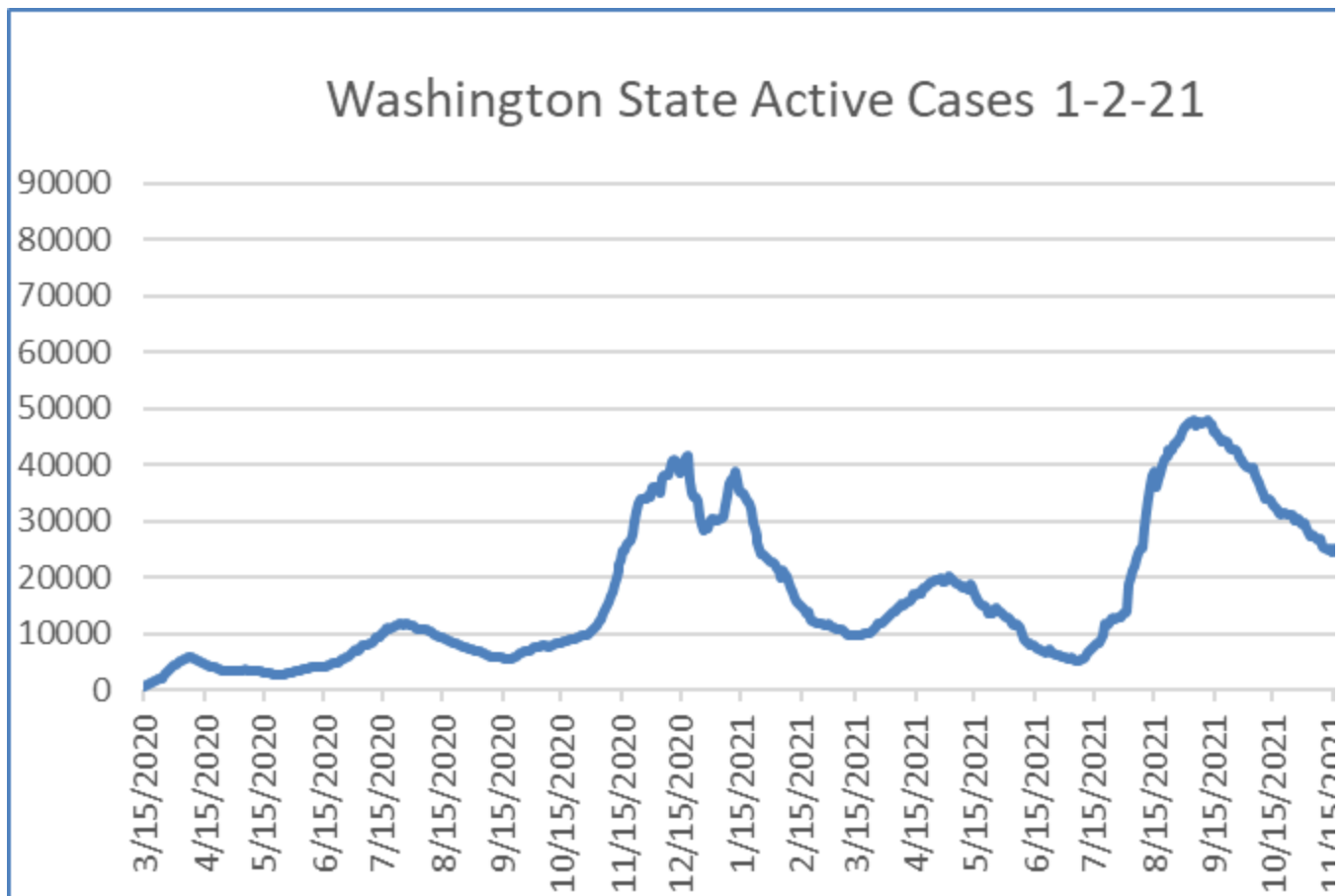

I know many of you believe you are properly informed on the covid situation but I would remind you of the saying made famous by Mark Twain: "There are three kinds of lies: lies, damned lies, and statistics." If you are following only one side of the covid issue, "following the science" (a mantra, not the scientific method itself), the narrative pushed by certain US agencies and most health boards, you are probably being confused with statistics.

March 2020 letters digitally signed by former NIH and CDC heads Drs. - Furthermore, Pfizer unblinded the trial participants, tested the Covid-19 vaccine on healthy and young individuals rather than the sick and elderly and did not track any subclinical biomarkers which would be valuable early warning signs of disease caused by the vaccines.
- Pfizer reported a 95% efficacy, which sounds like it protects you 95% of the time, but that 95% actually refers to the Relative Risk Reduction, while the Absolute Risk Reduction was only 0.84%. Moreover, the Pfizer clinical results are unreliable because Pfizer introduced immense subjectivity into the trial by leaving it up to the discretion of investigators whether or not to test participants for Covid-19. There were a total of 3,410 participants who had Covid-19 symptoms but were not tested for covid.
- Pfizer reported one of their 12-year-old trial participants who has been paralyzed to a wheelchair and forced to eat from a feeding tube for the last 10-months as "functional abdominal pain". Another whistleblower who was a regional director of Pfizer's clinical trials also reported to the FDA that Pfizer had falsified data, unblinded participants, and not followed up on testing participants who reported symptoms, but neither the FDA nor Pfizer ever investigated the issue.

- Pfizer's report authors had conflicts of interest with 84% of them either employed by Pfizer, owning Pfizer stock, receiving grants from Pfizer, hired as consultants by Pfizer, or previously running clinical trials for Pfizer. For example, two of the Pfizer report authors actually made \$9B in stock market profit directly from the Pfizer vaccines because they also happened to be the co-founders of BioNTech.

Dear public health board,

Thank you for taking public comment. As mayors and elected officials you wear many hats in your duties that inform your decision-making. Although I am a health care provider, I am new to following public health decisions and strategy as closely as I have for the past year. This is partly because of how your strategy or lack thereof and decisiveness or lack thereof informs the safety of my children in school. Our community is full of loud opinionated people fueled by misinformation. It also has a reasonable amount of quiet individuals that follow the science. I know you are feeling pressures to ignore the Covid crisis. However, you are the PUBLIC HEALTH board, your priorities need to be in hearing and understanding our public health situation and having that lead you to strategic action to support the medical professionals on the front line. I personally know multiple nurses who are now searching for new professions and many doctors who have chosen early retirement because of the pressures that this situation is creating. It is this lifesaving community that needs to be heard and strategically supported. I tried to take my daughter to urgent care this weekend and was told there are no available doctors. There is no certainty that our health care system will persist in it's fragile state. This is an endemic and it will be repeating itself time and time again.

It does our community and our health professionals a significant disservice to not assert outloud, as a board, that vaccinations are safe and effective (which is what happened at the previous meeting I observed). That was a clear indicator of how far removed from your obligations you have found yourselves. I have polled other counties health boards, most of which have one, most of the time more than one, voting health professionals on the board. We need medical professionals as voting members on the board or we need the health advisory board to make decisions based on facts and statistics and strategic considerations that prioritize public health. It would take the pressure off mayors to "represent their constituents." It would allow you to continue to say, we will do as we are advised from our advising groups. I would ask that the public health advisory board to take a step up and start making the decisions on how to support the medical community in combatting this endemic. We need stronger, more informed and innovative leadership. I ask each of you to consider: am I

prioritizing public health? And if not: what needs to change? A change is needed. Please rise to the challenge and learn to innovate, no more excuses, as the public health board the public is looking to you to improve our health and safety not appease extremist or wait and see. Thank you,
