AMENDMENT TO INTERLOCAL AGREEMENT FOR PROFESSIONAL SERVICES

Section III.2. of the Interlocal Agreement, "Scope of Work", shall be amended by deleting the following sentence of paragraph 3:

"KCHD will retain 40% of the overhead for JKPH and CCHD salary and benefits to cover KCHD's additional overhead." (deleted)

This Amendment shall be retroactive to April 28, 2008.
